Information for workshops in other European countries.

A lessee from abroad can have maintenance and repairs (including accident repairs) carried out without payment upon presentation of their Europa Tank & Service Card or their Volkswagen Leasing Europa Service Card. The costs for this are paid by the contact point Volkswagen Financial Services (uk) ltd.

Please check whether the vehicle data (chassis number and number plate) match the vehicle registration document. The Europa Service Card is valid from the date of registration or issue until the end of the agreed contract period. The contract period is shown in months. You will find this information in the lowest line of the Europa Service Card. If the costs for the work to be carried out are expected to exceed 150 euros (or the equivalent in the respective national currency), please obtain the approval of the contact point Volkswagen Financial Services (uk) ltd.

The following information is required for this purpose:

- ✓ contract number
- √ name/address
- √ official number plate/nationality
- √ chassis number
- ✓ mileage
- √ accident: yes/no
- ✓ estimated repair costs

Please also transfer this information to the invoice. This invoice must be issued to Volkswagen Financial Services (uk) ltd. Then have the customer sign the invoice and send it to the contact point within 14 days:


